Cookie Dollars 2008

Girls who participate in council and GSUSA-sponsored STUDIO 2-B destinations events are eligible to earn Cookie Dollars. For each box of Girl Scout cookies sold, the girl participant can choose to earn \$1.00 toward her destination event fee. Girls are selected for these events and there is no guarantee. On opening day of registration, if there are more applications than spaces for the event, a drawing will be held to select the participants on an individual basis.

- ◆ Each girl must pay a cash non-refundable deposit (\$100 non-refundable deposit for patrols.)
- ◆ Each girl may earn up to, but not more than, enough money to cover the cost of her event for Seattle by Storm, Shoot the Rapids. For GSWRC approved National & International STUDIO 2-B destinations and council sponsored patrols, the cost of event fees and transportation can be covered.
- ◆ Cookie Dollar money may only be earned by girls who are currently registered for a council, GSUSA STUDIO 2-B destination that takes place in the same year. Girls who are members of council sponsored patrols may only earn Cookie Dollars in the cookie sale taking place the same year as their patrol trip, not the sale a year before their trip.
- ◆ Girls must have participated in the Fall Sale to be eligible to participate in the Cookie Dollar Program.

This form is due April 1, 2008, but may be turned in any time before that date. Cookie Dollars earned will be dispersed in the following manner once this form has been processed:

- ◆ Council Sponsored STUDIO 2-B destinations event: money earned will be automatically transferred as a payment for the event.
- ◆ GSWRC approved National & International STUDIO 2-B destinations event: ***A copy of confirmed travel costs must accompany this form.*** The participant will be issued a check for the amount of Cookie Dollars earned but not to exceed costs. This is to be used to pay for event fee and/or transportation costs.
- ◆ Council Sponsored Patrols: A check will be made out to the patrol on behalf of each girl.
